<b>1. Meeting Summary</b>	Paul Rowland conducted the meeting. Minutes of the May 25, 2016 meeting were approved.	<b>Approved</b>
<b>2. TIP Business</b>	<p>Ben Wuthrich of WFRC presented a Board Modification to the Woods Cross project on 1500 South from 1350 West to 1100 West. This is not a request for additional funds, just an extension of the scope of the project. Woods Cross will cover any shortfall in costs that may result.</p> <p>Ben also informed the committee that the Draft 2017-2022 Transportation Improvement Program (TIP and the Conformity Analysis for the 2017-2022 TIP, Air Quality Memo 34a, has been posted for public comment. The TIP will be reviewed at TransCom Meeting on August 18, and a recommendation will be presented to the Council on August 25.</p>	<p><b>Approved</b></p> <p><b>Approved</b></p>
<b>3. Safety Data</b>	Clancy Black of UDOT gave a presentation about the UDOT crash data website that is available to Committee members. The Numetrics website has detailed crash data available once the user establishes an account with UDOT.	<b>Information</b>
<b>4. Functional Classification</b>	Wayne Bennion of WFRC gave an update to the Committee about functional classification maps for highways available on the UDOT website.	<b>Information</b>
<b>5. Air Quality Trends</b>	Kip Billings of WFRC shared information about current trends in air quality. Air quality monitor data shows that pollution levels for CO, PM10, PM2.5, and O3 (ozone) have been improving for the last 10-15 years. Vehicle emissions in particular are projected to decrease by 63% over the next 25 years due to Tier 3 vehicle and fuels standards and other vehicle emission improvements. The ozone standard was reduced from 75 ppb to 70 ppb effective October 2015. EPA will make final designations in October 2017 of ozone non-attainment areas based on State recommendations that will be sent to EPA later this year. It is expected that the Wasatch Front will be designated non-attainment for zone.	<b>Information</b>
<b>6. Other</b>	<p>Rex Harris of UDOT mentioned the State TAP program available to Committee members. A list of funded projects funded will be shared with the Committee. Of the 18 project applications, 15 were funded. The Program will be presented to the State Transportation Commission in September for approval.</p> <p>Thanks to Clinton City for today's refreshments.</p>	<b>Information</b>
