# Ogden/ Layton Area Technical Advisory Committee (TAC) May 31, 2023 10:00 AM Meeting Minutes

1. Action Item – March 29th Meeting Minutes ......Boyd Davis

Motion – Chad Boshell, Farmington Second – Ashley Tolman, Weber County

2. UDOT Traffic Monitoring......Kelly Njord [Agenda was modified to include this item]

A new traffic data set is available for all roads from major collector and higher classifications. Includes speeds and volumes. Can be shared for free with all local governments and their retained consultants. Search UDOT Traffic Data and you can create an account through Clear Guide. Users can collect data and even animations on specific intersections.

3. TIF/ TTIF Update ...... Andrea Olson

Andrea reviewed the project prioritization process for highway, active transportation, transit, and first/last mile improvements. Funding a project begins with nominations using an online Google form. Active transportation requires a 40% match, transit requires a 30% match. Nominations are due between June 26 to August 31.

4. Transportation Improvement Program (TIP) Business ....... Ben Wuthrich
 • Action – Modification for the 2023-2028 TIP
 PIN 16933 – Farmington City – Main Street (SR-106); Park Lane to Shepard Lane

This project was recommended in two phases for curb, gutter, and sidewalk on one side of the roadway, then the other. Initial estimated cost was \$4.3M. Issues with ROW purchase, residential access, construction easements, and irrigation canal/storm drainage led to significant cost increases. New project cost is estimated at \$8.0M. Farmington is requesting \$3.0M additional Surface Transportation Program (STP) funds and will cover the remaining \$0.7M.

• Action – Modification for the 2023-2028 TIP PIN 18807 – Farmington City – Commerce Drive Road; Burke Lane to 950 North

Farmington requested that the Commerce Drive project be withdrawn from the Surface Transportation Program (STP). This would return the \$ 3M back to the Ogden/ Layton STP. This was a result of Farmington being able to identify other funding that would enable the City to return the federal funding thereby eliminating the need for project federal requirements and reducing project costs.

### Information Item – New Projects for the Draft 2024-2029 TIP for Public Review

The 41 projects recommended at the March 29 meetings by the Ogden/Layton area and Salt Lake/West Valley area TACs have been approved by the WFRC Council for inclusion in the draft TIP.

### • Information Item – Review Schedule for the 2024-2029 TIP Process

After Trans Com review in June, the draft TIP is anticipated to go out for public review and comment in July. The WFRC Council is expected to make final approval in August.

### 4. West Point City Presentation ......Boyd Davis

Furthest west city in Davis County, hence the name. Features Schneiter's Bluff golf course! Population 12,500. There are 6 state highways intersecting the city. There are 5 round-a-bouts in a 2-mile section of 3000 West that are performing well for now. There is indication that the N/S flow is greater than E/W flow which could lead to imbalanced flow issues in the future (fewer gaps for E/W flow). Concrete round-a-bout holds up better than asphalt.
