2. Transportation Improvement Program (TIP) Business Ben Wuthrich

a. Board Modification for the 2022-2027 TIP

A project in Magna has encountered \$1.1M in cost overruns due to increased labor, fuel and material costs. Magna will provide an additional \$300K for the project and is requesting an additional \$850K from TAP funds.

The additional \$850K for this project will come from cost savings from completed projects and reduction in available funds for future projects.

The Committee asked if these types of cost increases would affect other projects in the program. Not all projects will experience cost overruns. If cost overruns are discovered, project sponsors are encouraged to contact Ben to discuss options for addressing the shortage. Some local governments have met shortages with local funds.

e. **TIP 2023-2028 Public Comment Summary Wayne Bennion**

Wayne reported that 80 public comments had been received. A complete document of comments and responses will be available following the close of the comment period.

Wayne noted three general themes for the comments submitted.

- increase investment in protected and separated bicycle and pedestrian facilities and complete the connections between existing facilities
- requests for more transit service and improvements in facilities
- requests for more safety improvements

4. Traffic Forecast Tool Bill Hereth

A very useful interactive map tool is available on the WFRC website. Bill demonstrated how the tool can display observed and forecast values for traffic volume, population, employment, and planned transportation projects. The tool can also show changes in the data from current levels to forecast years. Data from Streetlight is a promising new source of information for active transportation volumes which could be added to this utility in the future.

5. Discussion Item - 2023-2050 RTP Fiscally Constrained Phasing Jory Johner & Julie Bjornstad

Jory reviewed the Regional Transportation Plan (RTP) four-year update process. The Wasatch Choice Vision considers

- 1) Economic Development
- 2) Land Use
- 3) Transportation

Each of these vision elements is evaluated based on the 10 goals adopted by the WFRC Council. All modes are considered in the Plan development

- 1) Vehicles
- 2) Active Transportation
- 3) Transit
- 4) Telecommuting

Based on existing and forecast revenues, the Plan will prioritize projects by Phases 1, 2, and 3 (2032, 2042, and 2050).

RTP needs for the next 30 years exceed available revenues for all modes of transportation.

Highways: Need \$25.0B, Revenues \$17.7B

Transit: Need \$12.0B, Revenues \$5.2B

Active: Need \$1.1B, Revenues \$0.7B

Comments on the draft financially-constrained phasing of the 2023-2050 RTP are due by August 5, 2022.
