Karl Kuehn, Layton City, commented that it would be beneficial as a committee to know what cities and what counties are currently using FirstNet to get feedback on their experience whether it be positive or negative. He said that this will help in further decisions. There was a discussion held among the committee on cities and counties believed to be using FirstNet.

Chief Mathieu will contact Shae Cook, AT&T, to set up a time for him to give a demonstration on the deployables to the committee. Mark Cryder, Salt Lake City Police commented that a COW (Cell on Wings) was deployed during the Elizabeth Smart investigation and it provided great cell service.

Radio RFP Update [Recording 23:35]

Chief Mathieu stated that after all of the factors related to the point value system (functionality, technology and price) were gone through, it was determined that Harris was the winner of the RFP process. This was taken to the UCA Board, where it was approved to move forward in beginning contract negotiations. He stated that the difference in cost was quite significant.
