3. Final Draft – Highway Element of RPO Plan	Wayne Bennion, WFRC, distributed a map showing the highway element of the RPO Plan, which incorporated the changes discussed at the February meeting. Potential Modifications to Active Transportation Element of Draft RPO Plan	Wayne distributed two maps, one of the RPO active transportation element, and one of the recently updated County active transportation plan. The RPO discussed the importance of including active transportation (AT) in road projects, and the safety value of separated paths. Limited resources and the need for wayfinding signs were also brought up. Jim Bolser, Tooele City, reported that bike lanes have been striped on 1000 North, and that plans are under review for 100 East and Vine Street.
