1. Roll Call and Consent Agenda [00:00:10]

Hugh Van Wagenen, from WFRC, called the meeting to order at 9:17 am and extended a warm welcome to committee members and guests. Hugh explained that Mayor Petro was running late due to traffic, so the meeting would commence, with the approval of minutes deferred until Mayor Petro's arrival. Introductions were then conducted both in the room and online.

2. Chairs Report [00:03:59]

a. Bike Month Recap - Golden Spoke, other events: Hugh Van Wagenen of WFRC shared pictures and highlights from the 2024 Golden Spoke ride, during which participants traveled along interconnected trails from Ogden to Provo.

1a. ACTION: Approval of Minutes [00:09:51]

Mayor Petro called for a motion to approve the minutes of the Active Transportation Committee meeting held on April 9, 2023. Jeff Oyler from Davis County motioned for approval, which was seconded by Travis Mote from Willard City. The motion to approve the minutes without changes was unanimously carried.

b. Beehive Bikeways Update [00:11:07]

Ted Knowlton from WFRC provided an update on the Beehive Bikeways Initiative, which focuses on trail connectivity to expand upon the Golden Spoke Network, particularly by linking Wasatch Choice Centers. Ted informed members that WFRC has been engaging with communities within the region, and if any communities have not yet been met with, they will soon be contacted to schedule a meeting.

c. Utah Trail Network Programming [00:16:19]

Hugh Van Wagenen announced that the WFRC/MAG area has been allocated \$40.2 million for eight construction projects and two design projects. Hugh then provided a brief overview of each of the ten projects. Following this, Stephanie Tomlin from UDOT explained the next steps in the Utah Trail Network Initiative.

3. Public Comment [00:30:40]

4. Bike Utah Mobile Active Transportation Tours [00:31:12]

Chris Wiltsie from Bike Utah provided an overview of Mobile Active Transportation Tours (MATT), emphasizing their significance and the benefits of participation. Chris also informed members and guests about the upcoming MATT event scheduled to be held in New Jersey in April 2025.

5. TLC Projects 2024 and North Ogden Highlight [00:47:14]

Byron Head from WFRC announced the projects funded by the Transportation and Land Use Connections program for 2024, leveraging just over \$1.7 million. Byron detailed the seven projects with active transportation components, amounting to \$1.1 million.

At [00:52:32], Scott Hess from North Ogden City updated the group on his city's Active Transportation Plan, which was funded by the TLC program. The plan aims to increase trail usage by implementing a wayfinding system that connects North/South and East/West routes while addressing hillside challenges.

6. Community Highlight: Draper City Trails [01:06:14]

Rhett Ogden from Draper City discussed the trails within Draper City and their connections with surrounding areas. He highlighted recent efforts by the city to expand the trail network and outlined future plans to enhance active transportation within the city.
