<u>Welcome and Introductions:</u> Andrew Gruber welcomed the attendees and guests. Mr. Gruber explained that due to WFRC's air conditioning going out yesterday, the meeting was moved to virtual only and thanked participants for their flexibility. He gave a recap on the purpose of JPAC. Introductions and roll call **[00:01:44]**

Approval of June 2, 2022 meeting minutes [00:09:35] - UTA Trustee Carlton Christensen made a motion to approve the minutes from the June 2 meeting. The motion was seconded by Commissioner Gage Froerer. No discussion, and minutes were approved unanimously.

<u>Utah's Unified Transportation Plan Update (MPOs) [00:10:19]</u> - Andrew Gruber turned the time over to Julie Bjornstad, WFRC, who gave an update on Utah's Unified Transportation

Plan. Ms. Bjornstad let the members know that the plan was a 30 year plan, and they intend on elevating the importance of active transportation. Mr. Gruber noted that Utah's Unified Transportation Plan is nationally recognized as a model for collaboration. **[00:15:08]** Eileen Barron, UDOT, talked about the key themes of the plan.

Economic Impacts of Transportation Analysis [00:22:11] Ted Knowton, WFRC, talked about some of the economic benefits of Utah's Unified Transportation Plan, including transportation efficiency, creating jobs, and market access.

Transportation Electrification Updates [00:28:22] Carlton Christensen, UTA Trustee, talked about the Electrification Forum that will taking place on September 23, 2022 at the UTA Offices. **[00:32:00]** Ben Huot, UDOT, talked about a new formula program associated with the new infrastructure bill, National Electrical Vehicle Infrastructure (NEVI). Utah is proposed to receive approximately \$35Million over the next five years, to build electric charging infrastructure along the freeway corridors. The program has a requirement of building fast DC Chargers every 50 miles along those corridors. Utah has submitted a plan, and it is currently under review.

<u>TIF/TTIF Prioritization Update [00:37:30]</u> Andrew Gruber, WFRC, explained that the state funding that comes out of state sales tax is designated for state road and transit capacity projects. Ben Huot, UDOT, discussed the funding programs for TIF (Highway/Active Transportation) and TTIF (Transit/First & Last Mile) which are based on the Multimodal Framework. Mr. Huot notified the members of the intended outcomes and the timeline for the 2022-2023 update. Commissioner Gil Almquist noted to please take into account ADA accessibility and connectivity when working on these projects. Cameron Diehl, ULCT, asked about the implementation of TIF and TTIF, and the requirements for the Prioritization process, and there was some discussion.

Joint Statewide Grid Study [00:49:46] Andrew Jackson, Mountainland Association of Governments, talked about how the grid system (organized layout of Salt Lake City area roads) helps congestion in transportation, because it allows multiple options for connectivity. He spoke about Utah County needing a better grid system to help with their congestion issues near American Fork. The next step in the study is looking at funding to improve the grid systems. Carlton Christensen, UTA Trustee, also noted that the grid system helps public transit, and increases usage.

<u>UEOC Transportation Related Issues [01:02:14]</u> Carlos Braceras, UDOT, talked about the Unified Economic Opportunity Commission that was created last year and the associated working groups. Mr. Braceras gave an update on some of the projects and issues under discusison. Andrew Gruber, WFRC, highlighted that the UEOC and the Unified Transportation plan compliment each other. Mayor Jenny Wilson, SL County, stated that her county would like to be more involved in discussions around the Fifth Corridor.

<u>Statewide Growth Conversation [01:19:47]</u> Laura Hanson, GOPB, talked about the Statewide Growth Conversation, developed from the Unified Economic Commission which

was funded in the 2002 Legislative General Session. The group's focus is to bring forth facts, and realistic decisions regarding growth, while supporting the community's concerns.

Ms. Hanson asked the group: What is the most important thing the residents in your community need to hear during this Statewide Growth Conversation?

Commissioner Blaine Fackrell- Morgan County, Mayor Jeff Silvestrini- Millcreek, Mayor Julie Fullmer- Vineyard, Mayor Trent Staggs- Riverton, Mayor Dawn Ramsey -South Jordan all discussed concerns they are hearing in their communities, and what they think their constituents need to hear.

<u>Overview of the Statewide Federal Performance Measure Targets [01:33:42]</u> Ryan Bailey UDOT, shared the legislative requirements for the performance measures and target recommendations that UDOT has assembled. Mr. Bailey provided this information to see if anyone with JPAC had questions or concerns prior to their submission. There were no questions or comments.
