# 2. ACTION: Approval of Minutes [Recording 6:45].

After review of minutes, no comments were made. Chair Ramsey entertained a motion to approve the minutes of the Regional Growth Committee meeting held January 17, 2019. A motion was made by Tina Cannon, Morgan County; and seconded by Jeff Scott, Box Elder County to approve these minutes as written. Minutes were approved by unanimous vote.

# 3. Opportunity for Public Comment [Recording 7:30].

Mayor Ramsey welcomed public comment and opened for discussion. There was none.

#### 4. 2019 Legislative Session [Recording 7:50].

LaNiece Davenport, WFRC, highlighted a few important bills from the legislative session that will affect our region's growth, housing, and transportation (<u>handouts</u>). There was a record number of 73 passed (with an \$18 billion budget).

• <u>SB72 Sub 3</u>, Transportation Governance and Funding Revisions (Senator Harper); and <u>SB136 Sub 6</u>, Transportation Government Amendments (Harper/Schultz). Andrew Gruber spoke about SB72, which was passed as a furtherance to SB136, a significant tax reform bill that was passed last year to create the new state transit transportation investment fund authorizing state infrastructure dollars—to be spent on transit for the first time. It will also require UDOT to modify their prioritization process to look at a

broader plan called "U Vision" for their existing transportation investment fund for roads (which is about \$7 million per year). UDOT is asked to consider land use, housing, and economic development.

- <u>SB 136</u> is also working with the UTA governance structure. Mr. Gruber explained that a new task force was created, which leads to SB72. This made further modifications for local flexibility and usage.
- <u>SB34 Sub4</u>, Affordable Housing Modifications (Senator Anderegg). Mr. Gruber described SB34 as a housing bill corollary which is in sync with the SB72. Ms. Davenport highlighted changes as outlined on the summary handout, noting that on the Moderate Income Housing element, general plans need to be adopted by December 1, 2019. There is a requirement to do an annual report on progress on meeting needs and implementation.
- Tax Reform bills were not passed. There was much involvement by legislators to discuss whether to broaden the sales tax base, and lower the rate. They decided to set up a task force under <u>HB495</u>, Tax Restructuring and Equalization Task Force to hold public meetings and report back to the legislator in August for a special session. This will become broader than sales tax and include every county. Representative Mike Schultz will speak at a council meeting with WFRC next week.
- <u>Air Quality bills and Appropriations</u>. LaNiece Davenport indicated that a one-time allocation of \$28.8 million was received for air quality with an additional ongoing funding of \$35,400.

# 5. Wasatch Choice Vision [Recording 35:55].

Mr. Ted Knowlton, WFRC, addressed how to implement SB34. He discussed what is to come with the Regional Transportation Planning (RTP) and Wasatch Choice. The RGC, as a steering committee for RTP and Wasatch Choice, will recommend an adoption of that plan to the full council (a four-year process for growth and economic development) in May. The 2019-2050 RTP is one element of the Wasatch Choice Vision. Objectives are to work at a local level; then connect local planning to the regional level surrounding major transit to connect between homes and jobs; and project key growth areas. There was extensive roundtable discussion. High density issues were discussed.

There was a request to share more information from the leagues to the communities. Mr. Knowlton stressed that members of RGC come first as being local government representations; and second with the RGC. WFRC will help with training and assistance to understand the process. He encourages new members to visit the web site to review the process and highlight the final products.

# 6. Impacts of Community Design [Recording 1:12]

Reid Ewing, renowned professor from the University of Utah and member of RGC gave a presentation on types of changes and impacts of community design. He discussed recent research on the impact community design has on quality of life, depending on density and

diversity. Professor Ewing explained that the way intersections are designed are a more important variable than density and driving behavior. Due to time constraints, Professor Ewing will be presenting more information at future meetings.

# 7. Transportation and Land Use Connection Program (TLC) [Recording 1:30:56]. Meghan Townsend, Transportation Land Use Connection Program Manager, provided an update on ways the TLC program will provide technical assistance to communities with growth-related challenges during 2019 (such as help resolve issues and reach goals). The TLC is a partner with WFRC, Salt Lake County, UDOT and UTA. This partnership supports local governments with planning that relate to the Wasatch Choice Vision. There are \$1.5 million funds available.

Ms. Townsend also announced 15 awards for next year (5 are multi-jurisdictional).

# 8. Other Business [Recording 1:38].

<u>Upcoming Dates</u>: WFRC will host its first full Council meeting at these offices on March 28 at 2 PM. Afterwards, WFRC will have an Open House and celebration of its 50<sup>th</sup> Anniversary from 4-6 PM with everyone is invited.

# 9. ACTION: Adjournment [Recording 01:38:43].

Mayor Ramsey entertained a motion to adjourn the meeting. It was moved by Meghan Holbrook, and seconded by Erin Mendenhall that the meeting adjourn. Motion passed unanimously. The meeting was adjourned at 11:15 AM.

The Regional Transportation Plan (RTP) is the region's long-range blue-print for transportation based on the Wasatch Choice 2050 Vision and Goals. The RTP is adopted every four years. The Regional Growth Committee (RGC) is the steering committee for the RTP. The May meeting is the final milestone for RGC in this four-year planning cycle. At the conclusion of this agenda item, RGC will be asked to make a motion to the Wasatch Front Regional Council (WFRC) recommending adoption of the draft RTP at the Council meeting on May 23rd.

Before the motion, staff will provide an overview of the process that led to the RTP, the investments it contains, and a summary of projected impacts and benefits.

Staff invites you to familiarize yourself with the RTP by visiting the <u>2019-2050 RTP</u> and clicking on the document, interactive map, and Air Quality conformity determination links at the bottom of the page.

#### **BACKGROUND:**

On May 24, 2018, the WFRC Council endorsed the Wasatch Choice 2050 Preferred Vision Scenario which addresses roadway, transit, and bicycle needs from 2019 to 2050 (unconstrained by available financial resources). This endorsement directed staff, working with transportation agency partners and stakeholders, to phase these projects (phase one: 2019-2030, phase two: 2031-2040, phase three: 2041-2050, and unfunded projects).

On October 25, 2018, the WFRC Council authorized release of the draft phased, financially constrained RTP for public comment. The phased, financially constrained 2019-2050 RTP has been reviewed and commented on by the local governments, UDOT, UTA, stakeholders, and the general public during the public comment period held between October 29, 2018 and November 30, 2018.

WFRC staff reviewed the comments to respond to the input from the local governments, transportation partners, stakeholders and the public during the following months.

A second public comment period was held between February 11, 2019 and March 13, 2019, in response to regionally significant changes made.

#### **RECOMMENDATION:**

WFRC staff recommends that the Regional Growth Committee make a motion:

"I move that RGC recommend to the Wasatch Front Regional Council adoption of the final phased and financially constrained 2019-2050 Regional Transportation Plan and approve the Air Quality Conformity Memorandum Number 39 determination."

At the Regional Growth Committee (RGC) meeting, staff will highlight resources WFRC is and have been developing to assist communities to implement SB34 (Affordable Housing Modifications) and SB136 (Transportation Governance Amendments).

Staff will describe and seek input on data resources, analyses, and planning resources that will be made available to assist WFRC communities.

#### **BACKGROUND:**

The Utah State Legislature passed SB34 – Affordable Housing Modifications during the 2019 Legislative Session. SB34 encourages local communities to plan for housing for residents of all income levels, and coordinate that housing with transportation. Eligible communities are required to develop a moderate-income housing (MIH) plan as part of their general plan. Communities that are required to annually report on their MIH plan implementation must satisfy these requirements to remain eligible for state transportation investments.

Senate Bill 136 - Transportation Governance Amendments - enhances the coordination of transportation, land use, and economic development. It also authorizes additional funding for transit and local needs.
