## MINUTES WFRC || Regional Growth Committee January 16, 2025

WFRC Regional Growth Committee Meeting was held at WFRC Office, 41 N Rio Grande Street, Salt Lake City and via Zoom.

#### 1. Welcome & Consent Agenda [00:01:12]

At 9:20 a.m., Mayor Robert Dandoy of Roy City, Chair of the Regional Growth Committee, welcomed the members and guests to the meeting. Introductions were made both around the table and online.

**ACTION [00:06:13]** UTA Trustee, Beth Holbrook, made a motion to approve the Minutes of the RGC Meeting held October 10th, 2024. Mayor Lorin Palmer, Herriman City, seconded the motion. There was no discussion and the minutes were approved unanimously.

#### 2. Public Comment [00:06:57]

There was no public comment.

#### 3. Status Update for the Wasatch Choice Vision [00:07:20]

- a. Wasatch Choice Workshop Results and Next Steps [00:08:04] Ted Knowlton, WFRC Deputy Director, provided an overview of how WFRC is processing feedback from the recent Fall Workshop discussions focused on the Wasatch Front Region. He explained that the next steps in updating the Wasatch Choice Vision, a four-year process, include using the information gathered from local communities at these workshops to explore future scenarios (2024), develop a preferred approach (2025), prioritize projects (2026), and plan for adoption (2027). Ted also shared a preview of what each of these steps might look like.
- b. The process for considering exploratory transportation concepts [00:22:43] Andrew Gruber, WFRC Executive Director, provided a review of the Regional Growth Committee meeting from August 2024, where the group discussed how to strike the right balance between being aspirational and pragmatic as an organization and community. Andrew also highlighted the progress made since the last RGC meeting in efforts to achieve that balance.
- c. New project selection criteria: how transportation projects are considered for the Vision [00:31:46] Jory Johner, WFRC Long Range Planning Director, provided a high-level, step-by-step overview of the process for reviewing and screening transportation concepts for the upcoming RTP, as part of the Wasatch Choice initiative. Jory outlined three key components of the process: 1) the sources of the proposed projects, 2) the preliminary screening criteria for each mode, and 3) an overview of the technical criteria. He also discussed how, after considering these three components, the interaction between multimodal elements will be evaluated.

**[01:04:39]** Laura Hanson, Planning Director at the Governor's Office of Planning and Budget, provided an update on Governor Cox's State Housing Plan and his second-term strategic plan, <u>Built Here</u>. This plan aims to build 40,000 new housing units within centers identified in regional visions, such as the Wasatch Choice Vision

#### 4. Station Area Plan Certification - South Jordan TRAX stations [01:10:46]

Megan Padjen, Community and Economic Development Director at WFRC, provided an overview of the Station Area Planning goals and requirements. She introduced the South Jordan TRAX Station Area Plan, which includes four stations: the South Jordan portion of 5600 W Old Bingham Hwy, South Jordan Parkway, South Jordan Central, and Daybreak Parkway. Mayor Dawn Ramsey of South Jordan City and Steven Schaefermeyer, South Jordan City Planning Director, also presented an overview of the project and discussed its significance for South Jordan City and Daybreak residents.





**ACTION [01:30:35]:** Mayor Brandon Stanger of Clinton City made a motion to recommend the certification of the South Jordan TRAX Station Area Plan to the Wasatch Front Regional Council. Mayor Tamara Tran of Kaysville City seconded the motion. There was no discussion, and the motion passed unanimously

#### 5. <u>Utah Legislative Session Overview and Federal Transportation Update</u> [01:33:35]

Miranda Jones Cox, Government Affairs Manager at WFRC, provided a brief overview of what to expect in the upcoming 2025 Legislative session, covering topics such as transportation, housing, economic development, land use, and other related legislation and appropriations.

#### 6. Overview of the Utah Open and Public Meeting Act [01:45:28]

Mayor Dandoy, Regional Growth Committee Chair, explained that, as part of WFRC's compliance and annual training requirements, a video on the Utah Public and Open Meetings Act was sent in the initial RGC meeting email. He thanked those who have already completed the training and asked that everyone else please do so to fulfill the board's training requirements. He explained that the training video will also be sent in a follow-up email for those who have not yet completed it.

#### 7. Other Business and Adjournment [01:45:57]

Mayor Dandoy explained that the Wasatch Front Regional Council Meeting will take place next Thursday, January 23rd at 1:30 p.m., and the next Regional Growth Committee meeting will take place on Thursday, March 20th at 9:15 a.m.. Chair Report: 2025 Utah Legislative Session Overview

At the Wasatch Front Regional Council (WFRC) Regional Growth Committee meeting, the committee will hear an update on transportation and growth-related outcomes from the 2025 Legislative General Session.

#### **BACKGROUND:**

SUBJECT:

After multiple years of significant, new investments in Utah's multimodal transportation system, the state continued building on that investment in the 2025 Legislative Session to promote quality of life as Utah grows. And though this session did not lead to significant new transportation-related appropriations or policy shifts comparable to recent years, in part due to a relatively flat budget year for appropriators, a number of relevant transportation, housing, and economic development related bills and appropriations were passed and funded.

WFRC staff prepared this detailed <u>2025 Legislative Session Wrap Up</u>. Information on specific bills and appropriations can also be included in the <u>WFRC 2025 Bill Tracker</u> and <u>WFRC 2025 Appropriations Tracker</u>.

SUBJECT: 4A Transportation and Land Use Connection 2025 Awarded Projects

At the March 20th Regional Growth Committee (RGC) meeting, WFRC staff will provide an overview of the various planning technical assistance programs and opportunities that WFRC provides.

First, we will announce the 2025 Transportation and Land Use Connection (TLC) awarded projects. Following that, we will present Station Area Plans submitted by Sandy City for consideration for certification (Item 4B).

This year, the TLC program received the highest number of requests to date. Working with our program partners Salt Lake County, UDOT, and UTA, we are excited to announce thirteen projects that will receive FY26 funding. These projects include seven in the Ogden-Layton urban area, and six in the Salt Lake urban area. This totals over \$1.5 million in funded technical assistance, in addition to WFRC staff support. Our team is eager to work with these communities to help them achieve their visions.

#### **BACKGROUND:**

The <u>Wasatch Choice Vision</u> (WCV) provides a coordinated vision to address growth throughout the region that has involved each local government. WFRC knows that local implementation of the WCV can require substantial time and resources. To assist with local planning and the implementation of the Vision, WFRC provides several opportunities for member communities to receive technical assistance. This may be broadly, through TLC, or more specifically, such as funding and staff support with <u>Station Area Planning</u>.

The <u>Transportation and Land Use Connection Program</u> (TLC) provides technical assistance to local communities to help them achieve their goals and plan for growth. The TLC program is a partnership between WFRC and funding partners Salt Lake County, UDOT, and UTA. TLC projects support communities in developing their desired city and town centers, increased transportation choices, economic opportunity, and seek to maximize investments made in our region's infrastructure.

SUBJECT: 4B Station Area Plan Certification: Sandy City

**PREPARED BY:** Byron Head, Community Planner

At the March 20th Regional Growth Committee (RGC) meeting, WFRC staff will present an overview of the Station Area Plan in Sandy City that addresses five individual station areas. RGC will consider the certification request for these station areas in accordance with the Station Area Planning (SAP) components of state law and WFRC policy.

The Sandy Station Area Plan includes five stations: the Sandy City portion of the South Jordan FrontRunner station area; and the Historic Sandy, Sandy Expo, Sandy Civic Center, and Crescent View TRAX Blue Line station areas. Representatives from Sandy City will share highlights from this station area plan.

#### **BACKGROUND:**

<u>HB462</u>, passed in 2022, as amended in 2023, requires cities with fixed-guideway transit stations to develop a Station Area Plan for the area around the station, within ½ mile for rail and ¼ mile for bus rapid transit. <u>Station Area Plans</u> (SAPs) are intended to promote housing availability and affordability, sustainable environmental conditions, access to opportunities, and transportation choices and connections. The <u>SAP requirements</u> are consistent with communities' identification of <u>Wasatch Choice Vision</u> centers.

WFRC assists communities in their development of their station area plans, in partnership with UTA, GOEO, and the Mountainland Association of Governments (MAG). State law establishes that the Metropolitan Planning Organizations (MPOs – WFRC and MAG) have the responsibility to review SAPs and, in consultation with UTA, certify each for compliance with statutory requirements. WFRC does this consistent with the adopted policy for the certification review of SAPs.

WFRC has had the opportunity to assist Sandy City in planning around its station areas. The city chose to complete this process as a part of a comprehensive general plan update - the city's first in over 30 years. The city adopted the plan in January, and has submitted it to this body for review and certification.

#### **ACTION: Certify Sandy Station Area Plan**

In accordance with WFRC policy, staff has reviewed the SAP's consistency with state statute, and makes a positive recommendation for certification to the Regional Growth Committee.

SUBJECT: Wasatch Front Travel Demand Model Upgrade ("Activity-based Model")

WFRC staff will provide an overview of a major upgrade to the Wasatch Front Travel Demand Model (WF TDM). This enhancement will replace the major component of the WF TDM that simulates future household travel within the region. The new component is referred to as an activity-based model or ABM because it is a more robust simulation of how individuals travel to work and to meet other activity needs throughout a typical workday

#### **BACKGROUND:**

#### **Travel Models at WFRC**

WFRC, MAG, UDOT, and UTA partner to manage the WF TDM which is used extensively to support the long range transportation planning process, air quality conformity determinations, congestion management, and regional and local transportation project studies. The WF TDM supports transportation analyses for the combined Wasatch Front urban area valleys from Santaquin to Brigham City.

The first travel models for the Wasatch Front region were developed in the 1960's to support transportation planning and investments including the development of the urban freeway system. Like other planning tools, the WF TDM has been updated regularly as new needs and technologies are identified such as the addition of local and high capacity regional transit and consideration of toll lanes, retail delivery, and remote work.

#### **About ABMs**

ABMs simulate individuals traveling to meet their needs across a typical day and, therein, offer additional, detailed insight into our increasingly diverse travel patterns and set of transportation choices. By seeking to understand the movement of individuals, ABMs enable more precision in their representation of travel modes, multipurpose trip-chaining, and even responses to prices such as a toll or a change in transit fares.

The ABM model upgrade project is expected to be a 3-4 year project, jointly-funded by WFRC, MAG, UDOT, and UTA with completion timed to support analyses in 2029 in support of the next regional transportation plan (2031-2060RTP).

**SUBJECT:** Planning for Emerging Transportation Technologies

At the March 20th meeting, the Regional Growth Committee (RGC) will engage in its role as the steering committee for the Regional Transportation Plan (RTP), a central component of the Wasatch Choice Vision. The RTP is adopted every four years – the next RTP is expected to be adopted in May 2027 and will address transportation needs through the year 2055. During this meeting, staff will present and seek feedback on a key focus area of the RTP: improving the Region's resilience in the face of evolving external forces such as rapidly changing transportation technologies and shifting travel behaviors. Staff will introduce external forces of current focus for feedback and prioritization by RGC.

#### **BACKGROUND:**

The <u>Wasatch Choice Vision</u> is the shared framework to help communities and the region navigate growth challenges while preserving and enhancing quality of life for generations to come. The Vision is developed collaboratively with local governments, transportation agencies, and many other public and private sector partners. It integrates regional transportation planning with local land use and economic development efforts. The Vision's transportation component is the officially adopted <u>Regional Transportation Plan</u>. RGC oversees the ongoing update of the Wasatch Choice VIsion, ensuring alignment with evolving regional needs and priorities.
