Bill Cobabe commented that he attended a conference nearly 20 years ago where they spoke to rapidly emerging technology that was changing the environment and that we are seeing this come to play in so many aspects of our lives. Transportation is in a constant state of flux and our children will have to deal with and work with technology and solutions and questions that we cannot even think of right now.
