Parks and Public Spaces Mikala Jordan, WFRC Community Planner	Mikala Jordan, WFRC Community Planner, opened with a presentation on parks and public spaces and how WFRC can offer support in that space and technical assistance opportunities. <p>Park Rx Utah Introduction</p> <p>Sarah Kinnison, Health Educator and Program Manager</p>	<p>Sarah Kinnison, Health Educator and Program Manager, gave an introduction to Park Rx Utah, which was founded in 2018 with partners ranging from public health, park and recreation, healthcare, research, etc. Discussed getting outside in the name of health through prescribed outdoor time. Sarah went over the benefits of spending time outdoors like decreasing anxiety and depression, improving glucose levels in patients with diabetes, decreasing high blood pressure, and increased opportunities to improve and retain sustainable health behaviors. Sarah discussed that park prescriptions can address health equity issues so that everyone has a fair and just opportunity to be healthy. Household and Jobs Forecast Viewer WFRC Analytics Group	<p>Bert Granberg, WFRC Director of Analytics, opened up with a presentation of the Draft Household and Job Forecast (2021-2050). This forecast uses state of the practice tools, regional data resources, community feedback, and professional judgment to forecast the distribution of population, households, and employment by major sector, annually through 2050 - using GPI county control totals. These projections are provided at two scales:</p> <ul style="list-style-type: none"> • Traffic Analysis Zone (TAZ) • "City Area" summary zones (aggregations of TAZ) <p>These projects inform the Wasatch Front Travel Demand Model, the RTP and other project prioritization metrics, and environmental studies and other economic and resource analyses.</p> <p>Bert walked through the Household and Job Forecast Viewer (Preliminary Draft 2023-2050 RTP) and discussed the various data available for viewing.</p> <p>For questions and additional information, reach out to Bert at bgranberg@wfrc.org.</p>	None Required
2023 RTP Phased Fiscally Constrained Projects WFRC Long Range Planning Group	<p>Jory Johner, WFRC Manager of the Long-Range Planning Group, presented on the draft Fiscal Constraint Phasing for the 2023-2050 RTP. Jory Gave an overview of the Wasatch Choice Vision and the Regional Transportation Plan.</p> <p>Jory discussed updates to the Unified Plan Financial Model Development that is used for the long range plans across the state. These updates include growth rates, project costs and operating expenses, assumed new local option sales taxes, state funding for active transportation (TIF AT, TTIF, FLM), and IJJA.</p> <p>Julie Bjornstad, WFRC Senior Transportation Planner, gave an overview of funding available by mode in the draft 2023-2050 RTP.
