Elected Official Input on Draft RPO Plan	Wayne Bennion reviewed the following input from elected officials regarding the draft RPO Plan. 1) The Plan should include an alignment for the west end of the SR-201 extension that has received more discussion with local government officials. After a preliminary look at six alignments, UDOT is in the process of conducting a detailed evaluation of two proposed alignments. 2) It may be worthwhile to somehow show road improvements over the Oquirrhs. 3) More bicycle trails may be desirable in Grantsville. 4) Several minor map edits. 5) South Mountain Road improvements should be included. Midvalley Highway	Oanh Le-Spradlin, the UDOT project manager for Midvalley Highway, reported that the horizontal alignment has been completed and that full design completion is anticipated in fall 2018. A question was asked whether bike lanes were planned and Ms. Le-Spradlin responded that environmental clearance had not as yet been pursued for such lanes. The project team is investigating whether box culverts can be afforded. RPO members requested that the need for box culverts be addressed, including sufficient size (14x20) for farm equipment and animals. I-80 Bridge Replacement Projects	Kevin Farley, with Michael Baker International, showed drawings of the preliminary design and alignments for upcoming bridge replacement projects at SR-36 and I-80, and the two bridges on I-80 over the railroad just east of where SR-201 comes into Tooele County. Both projects are scheduled to construct between spring and fall of 2018. In addition, both projects are being designed to accommodate the longer term planned widening of I-80 to 3 lanes in each direction. Mr. Farley and the RPO discussed further details of these projects.
