#### 1. Approve Minutes (2:00)

Mayor Marshall, Motion. Commissioner Tripp, 2<sup>nd</sup>. **Approved.** 

#### 2. Wasatch Choice 2050 Vision Implementation Workshop (2:35)

Wayne Bennion talked about the strategies of the WC2050 Vision:

- 1. Provide Transportation Choices
- 2. Support Housing Options
- 3. Preserve Open Space
- 4. Link Economic Development with Transportation and Housing

Vision implementation workshops (10) will be held throughout the region including Tooele Valley. Workshops last about 2 hours. Workshop discussion will address:

- SB-34
- TIF/TTIF Process
- Innovative Financing (Transportation Reinvestment Zones, Opportunity Zones)
- Challenges (market demands, physical, political, partnering, financial)

In response to a question, Wayne explained that the agencies partnering in the WC2050 effort include local governments, WFRC, UDOT, UTA, ULCT, UAC, and various Chambers of Commerce. Tooele Valley has representatives serving with WFRC. The implementation workshop for Tooele Valley will be in November, probably on a Monday. There was a request to avoid the November 11<sup>th</sup> date and also to not be later in the month with possible conflicts with the Thanksgiving holiday.

Wayne provided a handout explaining some of the details about the WC2050 effort.

#### 3. Midvalley Highway Update (21:10)

Ames Construction was awarded the contract. Construction is expected to take 525 days with ground breaking on September 26, 2019 and completion anticipated November 20, 2021. Surcharging is the first task. The borrow pits to be used are in Stansbury and Granstville so this will generate some truck traffic from those sites. There is a Facebook page and a website for this project. Under the UDOT Facebook page search for "tooelevalleyconstructionprojects" or from the internet search for UDOT.utah.gov\tooelevalleyconstruction.

For the I-80 westbound auxiliary lane addition, bids will be opened spring of 2020 and construction should begin by summer 2020.

#### 4. <u>I-80 Bridge Replacements Update (24:10)</u>

The Black Rock project is moving forward. Traffic will be moved entirely to the new bridge from I-80 to SR-36 in October. The construction team is hoping to finalize agreements with UPRR in the near future.

#### 5. Transit Study Update (30:40)

Levi Roberts of UTA reported on the status of the Transit Feasibility Study.

The Study will begin the end of September and will take about 9 months. A steering committee will be formed and will meet bi-monthly and include representation from local elected officials. Project management will meet bi-weekly, usually by teleconference, and Levi asked for the name of a staff person from each agency to participate.

#### 6. Area Corridor Study Update (37:20)

Workscope is being drafted. RFP is expected to be issued within 2-3 months.

#### 7. Other Business (38:25)

Grant Farnsworth of UDOT sent an e-mail regarding State funds that will be available for active transportation projects. A meeting will be held September 30 to discuss.

The deadline for Letters Of Intent to WFRC for TLC projects is September 26, 2019. WFRC and UDOT will share Tooele Valley CMAQ fund information in the near future.

The Joint Highway Committee is now being administered by the Utah League of Cities and Towns and Utah Association of Counties. Tooele Valley RPO members expressed a preference to keep the meetings under local government guidance. The next meeting will be September 27, 2019. There is opportunity for Tooele County to have representation on this Committee.

The WFRC website has useful resources including the Tooele Valley Highway Phasing map, Transit and Active Transportation information, and other materials of interest. Public comments will also be added to the page.
