



5. SR-36 and I-80 Updates (1:45p)


Becky Stromness of UDOT gave a progress report. UDOT's goal is to advertise the project to add a southbound lane on SR-36 in February 2024, with construction expected next summer. Project development work is expected to begin in the near future for adding a northbound lane on SR-36. A question was posed about shifting the roadway to the west when the additional lanes are added in order to reduce property impacts in Lake Point. Becky indicated that it could be looked at.






6. Draft 2050 Tooele Valley Long Range Transportation Plan (1:50p)

Wayne Bennion of WFRC reported that based on input from the local governments, the preliminary draft highway phasing to 2050 has been updated. The maps below show highway and bicycle needs for the next approximately 30 years, but are not financially constrained. The operational improvements on the highway map involve upgrading from 2-lanes to 3-lanes (a center passing/turning lane) and pavement reconstruction, as well as safety and other improvements. There was a question about adding a signal in Grantsville. UDOT will check on the status. A few additional updates to the phasing were suggested.

7. Other Business (2:06p)

UDOT is holding workshops throughout the state to share information about and request input on the Utah Trail Network for paved trails connecting communities. \$45 million dollars a year has been designated by the State Legislature to construct and maintain this network. A workshop will be held at the Deseret Peak Complex on September 27th.

Letters of intent are due September 28th for Transportation and Land Use Connection Program (TLC) funds. Also, a mandatory workshop will be held October 5th 2023, 3:00 pm at the WFRC

office for those wanting to apply for Community Development Block Grant (CDBG) funding this cycle.

Other discretionary grants are available and deadlines are approaching. Rosie will send an email with examples.
