## 2. **ACTION: Approve 2024-2050 Tooele Valley Long Range Transportation Plan [00:03:45]**

Wayne Bennion, WFRC, shared materials documenting the Tooele Valley Long Range Transportation Plan. Wayne noted that the Plan there are three parts to the plan; (i) [Highway Phasing](#), (ii) [Active Transportation Phasing](#), and (iii) [Transit](#). ## 3. **Congestion Mitigation Air Quality (CMAQ) Program Information [00:25:15]**

Tyler Lang, UDOT, provided a brief overview of the CMAQ program. CMAQ provides federal funding for transportation projects and programs that focus on reducing congestion and improving air quality. The Tooele Valley area has been designated as non-attainment for ozone and particulate matter (PM2.5), granting it eligibility for CMAQ funds. Tyler reported that Letters of Intent for CMAQ funding must be submitted by October 18, 2024, and applications for eligible projects must be submitted by November 15, 2024.

## 4. **SR-36 and I-80 Updates [00:35:14]**

Sarah Kaye, UDOT, reported that construction has begun on SR-36, with most of the work taking place at night to minimize driver impact. Paving is anticipated to start in late September, and a winter shutdown is expected in October. Phase two is scheduled to continue in April 2025, with substantial completion of the project scheduled for May 2025. Sarah noted that an auxiliary lane will be added on eastbound I-80 from Exit 99 to the SR-201 on-ramp as part of the project in 2025.

## 5. **WFRC Comprehensive Safety Action Plan [00:42:00]**

Wayne Bennion, WFRC, reported that the [Comprehensive Safety Action Plan](#) (CSAP) was approved by the WFRC Council at their March 28, 2024 meeting. He noted that an analysis of safety needs was completed, which included crash history, roadway risk factors, and input from communities throughout Weber, Davis, Salt Lake, Tooele, Morgan, and southern Box Elder counties.
