1. Approval of Minutes [Recording: 00:04:00]

Mayor Applegarth brought attention to the minutes of the August 18, 2016 meeting and asked if there were any questions. There were none. Mayor Brent Marshall moved that the minutes of the Trans Com meeting be approved as written. Mayor Carmen Freeman seconded the motion, and the voting was unanimous.

2. Opportunity for Public Comment [Recording: 00:04:20]

Mayor Applegarth opened the meeting up for public comments. There were none.

3. Transportation Improvement Program (TIP) [Recording: 00:08:08]

a. ACTION: Board Modifications to the 2017-2022 TIP [Recording: 00:08:15]

Ben Wuthrich, WFRC, reported that since the last meeting of Trans Com, WFRC received requests to modify the current 2017-2022 Transportation Improvement Program (TIP). The modification requiring action from Trans Com includes six projects; one is a funding exchange and five are changes in scope. He discussed each project and there was some group discussion.

Mayor Brent Marshall moved to approve the resolution to modify the 2017-2022 TIP. Mayor JoAnn Seghini seconded the motion and the voting was unanimous.

b. Information: 2017-2022 Transportation Improvement Program (TIP) [Recording: 00:21:49]

Mr. Wuthrich then referred Trans Com members to the information in the meeting packet regarding the 2017-2022 Transportation Improvement Program (TIP), Amendment One, which the WFRC Regional Council approved at their October 27, 2016 meeting. Since detailed information is included in the packet, he asked the group if there were any questions or points for discussion. The group felt comfortable with the information presented, so no further explanations were needed.

c. Information: Letters of Intent (LOI) received for 2018-2023 Surface Transportation Program (STP) Congestion Mitigation/Air Quality (CMAQ) Program, 2019 Transportation Alternatives Program (TAP), and 2017 Transportation and Land Use Connection (TLC) Program [Recording: 00:23:09]

Mr. Wuthrich also discussed the letters of intent that have been received since late September 2016, when the request was sent out to local jurisdictions and other interested entities. He noted that if there were projects that Trans Com members were aware of, for which letters of intent had not yet been submitted, they could reach out to a member of the WFRC staff to complete their submissions. He referred to the information in the packet while discussing the process going forward. There was some discussion among the group.

4. Information: Utah Transit Authority Draft 2017 Goals and Budget [Recording: 00:33:18] Matt Sibul, UTA Chief Planning Officer, presented UTA's draft budget and gave opportunity for Trans Com members to review and provide input. Mr. Sibul also reviewed the 2017 goals planned for UTA. Robert McKinley, UTA Board of Trustees, also welcomed any comments on both the budget and the goals. Mayor Bill Applegarth suggested that more interaction be developed between city councils and UTA, to create personalization on a community level.

5. Information: Utah Department of Transportation Priorities for the 2018-2023 Statewide Transportation Improvement Program (STIP) [Recording: 00:59:08]

Presentations were made by Rex Harris, UDOT Region 1 Program Manager, and Charles Mason-Hill, UDOT Region 2 Preconstruction Engineer, who shared their respective region's priorities for the 2018-2023 STIP. Members were encouraged to provide any comments regarding highway needs and there was group discussion.

7. Other Business

[Recording: 00:05:00] Mayor JoAnn Seghini informed the group that she brought copies of Midvale City's ordinance that makes it illegal for pedestrians to step in the roadway or otherwise distract drivers. This was adopted to prevent panhandling and has proven to be successful.
