1. Introductions and Consent Agenda

Mayor Mark Shephard, Chair called the meeting to order at 2:04pm and asked for a motion to approve the minutes of the last meeting.

a. **[00:00:30] ACTION:** Carlton Christensen, UTA Trustee, made a motion to approve the <u>Minutes</u> of the August 18, 2022 meeting, seconded by Commissioner Jim Harvey, Weber County. No discussion, approved unanimously.

Introductions were made in the room and, Andrea Pearson, WFRC, introduced the online attendees.

2. Public Comment - [00:02:30]

Mayor Shepherd opened the meeting to public comments. There were no public comments made.

3. Chair Report - [00:02:40]

Mayor Shepherd talked about Governor Spencer Cox's trail system announcement. He also encouraged all members to attend the Wasatch Choice Fall Transportation Workshops in their respective areas. Andrew Gruber, WFRC made a few comments about the upcoming press conference for Governor Cox's announcement regarding the proposed trail system for the State of Utah.

4. Transportation Improvement Program (TIP) - [00:06:12]

- a. Mayor Shepherd brought attention to the <u>Report</u> on Board Modifications to the 2023-2028 TIP, which were approved by the Council in their meeting on October 27, and asked if there were any questions. There were none.
- b. [00:06:37] Mayor Shepherd then turned the time to Ben Wuthrich, WFRC, who briefly reviewed each project that was part of the proposed Board Modifications.[00:23:43] <u>ACTION</u>: Mayor Rob Dahle made a motion to approve these Board Modifications to the 2023-2028 TIP, as presented. The motion was seconded by Commissioner Jim Harvey. No discussion, approved unanimously.

5. Utah Transit Authority and Utah Department of Transportation Updates

- a. **[00:26:15]** Carlton Christensen, UTA Trustee, discussed the <u>UTA Tentative 2023</u> <u>Budget</u>, and gave some of the highlights, upcoming plans, and reviewed the five year capital goals of UTA. Trustee Christensen let the Trans Com members know that UTA's Board plans to adopt the budget at their meeting on December 21, 2022.
- b. **[00:48:09]** Brian Allen, UDOT, discussed the <u>FrontRunner Strategic Double</u> <u>Tracking</u> project including the scope, schedule and budget. Mr. Allen also discussed the goals of the project and thanked UTA for their partnership on this project.
- c. **[01:10:43]** Ben Huot, UDOT, gave an update on the <u>Transportation Investment</u> <u>Fund/ Transit Transportation Investment Fund</u>, reviewing the multimodal framework and the project types included. Mr. Huot reviewed the goals and timeline of the prioritization program.
- d. **[01:18:55]** Brad Palmer, UDOT, gave a <u>presentation</u> on several current and upcoming funded capacity projects that UDOT is responsible for in the Salt Lake and Tooele areas. **[01:38:01]** Brett Slater, UDOT, gave a similar <u>update</u> on environmental studies and capacity projects in the northern area of the WFRC region.

6. Other Business and Adjournment - [01:51:59]

Andrew Gruber, WFRC, recognized UDOT for their efficient, well-organized operation, with the many projects they are executing. Trans Com Chair Mark Shephard thanked Tooele County Councilmember Tom Tripp for his service on Trans Com, and his time with WFRC, as this is his last year. Mayor Shepherd noted that the next Trans Com meeting will be on February 16, 2023 and entertained a motion to adjourn. Mayor Joe Smolka made a motion

to adjourn, seconded by Mayor Rob Dahle. The vote was unanimous in the affirmative and the meeting adjourned at 4:02pm.
