#### 1. Introductions and Consent Agenda [00:00:03]

Mayor Mark Shepherd, Chair, called the meeting to order and introductions were made, via roll call. **[00:02:34]** Mayor Shepherd brought attention to the minutes of the June 16, 2022 meeting and asked if there were any questions or comments. There were none. UTA Trustee Beth Holbrook made a motion that the minutes of the Trans Com meeting be approved as written. Commissioner Jim Harvey seconded the motion, and the voting was unanimous in the affirmative.

Andrew Gruber, WFRC, provided an update on federal and state legislative items of interest.

#### 3. Public Comment [00:16:27]

Mayor Shepherd opened the meeting to public comment. There were no public comments.

## 4. Transportation Improvement Program (TIP) [00:16:39]

Mayor Shepherd turned the time to Ben Wuthrich, WFRC, who reported on the Transportation Improvement Program (TIP).

#### a. ACTION: Board Modifications to the 2022-2027 TIP

Mr. Wuthrich stated that since the last meeting of Trans Com, WFRC received requests to modify the 2022-2027 TIP. This modification requires action from the Regional Council and the Transportation Commission / UDOT but does not require a new air quality conformity analysis or a 30-day public comment period. The requested modification is listed with the attached resolution and Mr. Wuthrich presented an overview of each project.[00:24:21] Mayor Rob Dahle made a motion to recommend the Regional Council approve the resolution to modify the 2022-2027 TIP as requested. Salt Lake City Councilmember Dan Dugan seconded the motion and the vote was unanimous in the affirmative.

#### b. ACTION: Recommend Approval of 2023-2028 TIP [00:25:11]

Mr. Wuthrich continued, by presenting the 2023-2028 TIP. A draft 2023-2028 TIP was reviewed by Trans Com in June (as delegated by the Regional Council) and approved to release for public review and comment. The public comment period extended from June 25 through July 30, 2022. The extensive outreach included distribution to thousands of stakeholders about opportunities to provide public comment, an interactive map on WFRC's website, a news release, two open houses, coordination with UDOT and UTA, and social media posts. A summary of the public comments with respective responses is included in the meeting materials, along with the list of individual comments received. WFRC staff will work with local governments, UDOT, and UTA to address individual comments as appropriate.

An analysis of the TIP completed by the WFRC staff shows that the 2023-2028 TIP conforms to the state air quality plans. The Salt Lake/ West Valley and the Ogden/ Layton Area Technical Advisory Committees (TACs) have also reviewed the 2023-2028 TIP. [00:44:00] Kevin Cromar, Air Quality Board Member, made a motion to recommend to the Regional Council the adoption of the resolution approving the 2023-2028 Transportation Improvement Program (TIP) and the corresponding air quality conformity finding. Salt Lake City Councilmember Dan Dugan seconded the motion and the vote was unanimous in the affirmative.

#### 5. WFRC Funding Opportunities for Local Governments [00:44:36]

The Wasatch Front Regional Council administers or assists with nine programs, including two new programs, denoted below by an asterisk. Built in 1980, this structure carries SR-201 over 3200 W in Salt Lake County and has been a vital part of the infrastructure network in this area, with an average annual daily traffic (AADT) of 88,000 with approximately 20% truck traffic. Initially this project was approved to perform a bridge deck preservation treatment on the structure in an attempt to extend the service life of this facility. This project was planned to take place in 2024. However, recent inspection reports indicate that the existing bridge deck has deteriorated beyond what can be addressed with a preservation project. It is proposed that the scope of this project be modified to include a full bridge deck replacement and be moved to the 2023 Structures Rehabilitation and Replacement Program.

In April the Transportation Commission approved the 'bridge list', a list of 90 bridges prioritized based on condition and load restrictions eligible for funding from the Infrastructure Investment & Jobs Act Bridge Formula Program (BFP). The following locally owned Weber County bridges are on the approved BFP Structure List:

057040F - North Fork Bridge, east of Liberty,

057001F - Warren Canal Bridge on 5900 West in Weber County

The Department proposes to transfer PIN 17371 (replacement of structure 057040F) from the 2023 Structures Program to the BFP. This structure is currently in poor condition. In addition, it is proposed that the replacement of structure 057001F be added to this project. This structure is currently in low-fair condition. In 2017 the "Managed Motorways" study was completed. The defined implementation showed a significant operational improvement to mainline I-15. However, there are several items that need further exploration regarding how implementation would benefit the system and what it would ultimately look like. These include but are not limited to:

- Understanding of the true operational benefit
- Impacts to connecting arterials
- Questions regarding system-to-system meters
- Construction/Operational needs
- What elements define a successful implementation
- Which routes are managed

UDOT is requesting funding to evaluate these items and determine if a modified implementation of "coordinated ramp metering" is more appropriate for the Utah freeways. The end results of this study would be a more refined recommendation for an advanced ramp meter system. The anticipated cost of this study is \$500,000. It is anticipated it would take approximately 9 months to complete.

- (2) Finds that the TIP conforms to and is consistent with the State Implementation Plan for Salt Lake, Davis, western Weber, and southern Box Elder Counties, and
- (3) Finds that the development of the Transportation Improvement Program is based on a currently certified transportation planning process.

In 2018, West Valley City (WVC) applied for \$5,767,800 from the Surface Transportation Program (STP) to reconstruct and widen Parkway Boulevard between Mountain View Corridor (MVC) and 6400 West. The project team has recently completed Plan-in-Hand (PIH) and is currently preparing the Plans, Specifications, & Estimate (PS&E) package. The PIH estimate came in at \$11,200,000, approximately \$5.4 million above the current programmed amount. Some of the major differences between the 2018 Concept Report and the PIH estimate include the following: • An additional \$1.2M in right-of-way, • An additional \$750K in design/construction engineering services, • An additional \$2.2M in Roadway and Drainage Items, • \$600K in Mobilization, • \$400K in Traffic Control, • \$600K in Drainage Pipe/Structures. West Valley is requesting an additional \$1,900,000 in Urban Surface Transportation Program Funds and will provide the remaining \$3,532,200 from various Local funding sources.

The scope of the I-80; MP 50 to 60 project is to remove the top 1.5" of existing asphalt and replace it with 1.5" of Stone Matrix Asphalt (SMA). An updated project estimate was recently completed using unit pricing from recent bids of similar scope. This updated estimate showed a need to increase the cost for several bid items including mobilization, SMA, and rotomilling. This project is scheduled to advertise in November 2022. The additional funds would come from the High Volume Pavement Preservation Program.

The Weber River Parkway Trail will pave the surface and improve the alignment of the trail for a more safe path. One of the hurdles with completing this section of trail has been a US-89 crossing. Phase III of the trail will complete the section between Cottonwood Drive to the US-89 Crossing, a section of trail roughly 0.417 miles in length. Since the project was reviewed and approved, efforts by the City have secured additional funding and are currently improving Phase III of the trail. South Weber requests that the funding for Phase III be moved to Phase IV of the Weber River Parkway Trailhead Connection, which would connect the north side of I-84 and west of Weber River Crossing (approximately 0.625 miles).
