2. **Transportation Improvement Program (TIP) Business** - Ben Wuthrich

a. **Action** – Board Modification for the 2023-2028 TIP

West Valley City – Parkway Blvd (2700 So); MVC to 6400 West.

In 2018, West Valley City (WVC) applied for \$5,767,800 from the Surface Transportation Program (STP) to reconstruct and widen Parkway Boulevard between Mountain View Corridor (MVC) and 6400 West. As the project completed the Plan-in-hand (PIH), the updated project estimated cost came in at \$11,200,000, approximately \$5.4 million above the current programmed amount.

Some of the major differences between the 2018 Concept Report and the PIH estimate included: • An additional \$1.2M in right-of-way, • An additional \$750K in design/construction engineering services, • An additional \$2.2M in Roadway and Drainage Items, • \$600K in Mobilization, • \$400K in Traffic Control, • \$600K in Drainage Pipe/Structures.

West Valley requested an additional \$1,900,000 in Urban Surface Transportation Program Funds and will provide the remaining \$3,532,200 from various Local funding sources.

Motion – John Miller. Recommend to Trans Com that the STP allocation for this project be increased by \$1.9M.

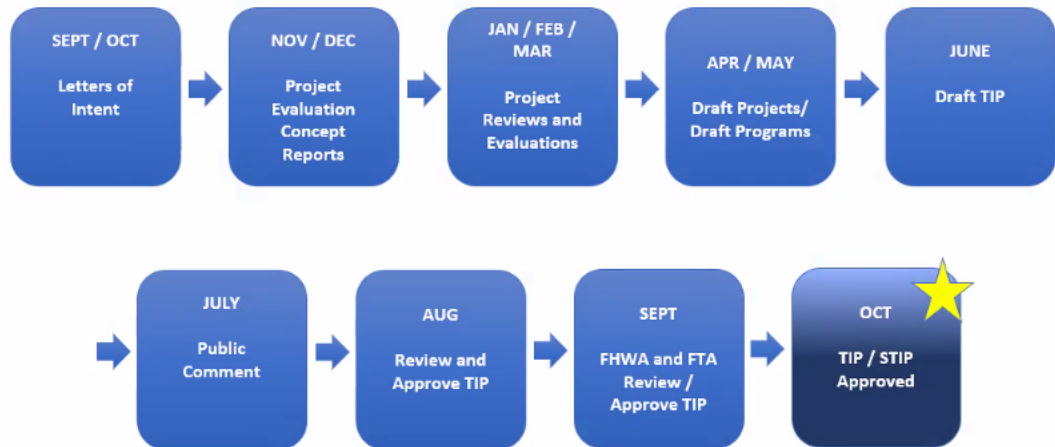

3. **Information Item** – UTA TDM Annual Report - Michael Goldman

UTA Rideshare has a staff of 11 people. The Salt Lake/West Valley program reduced VMT by 3.7M last year. High fuel prices are attracting more users. 60 vans were added last year, 40 more will be added next year.

4. **Information Item** – ATMS Annual Report - Tyler Laing

ITS began growing (about 8.6% annually) following the 2002 Olympics. ITS includes CCTV cameras, VMS signs, vehicle detection, and other technology. Fiber optic network is also expanding. New digital cameras improve video quality. New TOC software from Southwest Research Institute to replace previous software that was installed 15 years ago. Full color VMS signs are being installed.

There were 22 wrong-way driver crashes last year that resulted in 8 fatalities. Additional signage and detection are being added to prevent wrong-way driving. A high percentage

of wrong-way crashes involve impaired drivers. UDOT is also considering design standards to distinguish on-ramps from off-ramps.

Users can make unlimited rides for an annual fee of \$75.00. New Executive Director is Stan Penfold. Ogden and Salt Lake services will be expanding, and adding e-bikes.

6. **City Project Report/ Information** – How Municipal participation in Transit service benefits City goals - Salt Lake City.

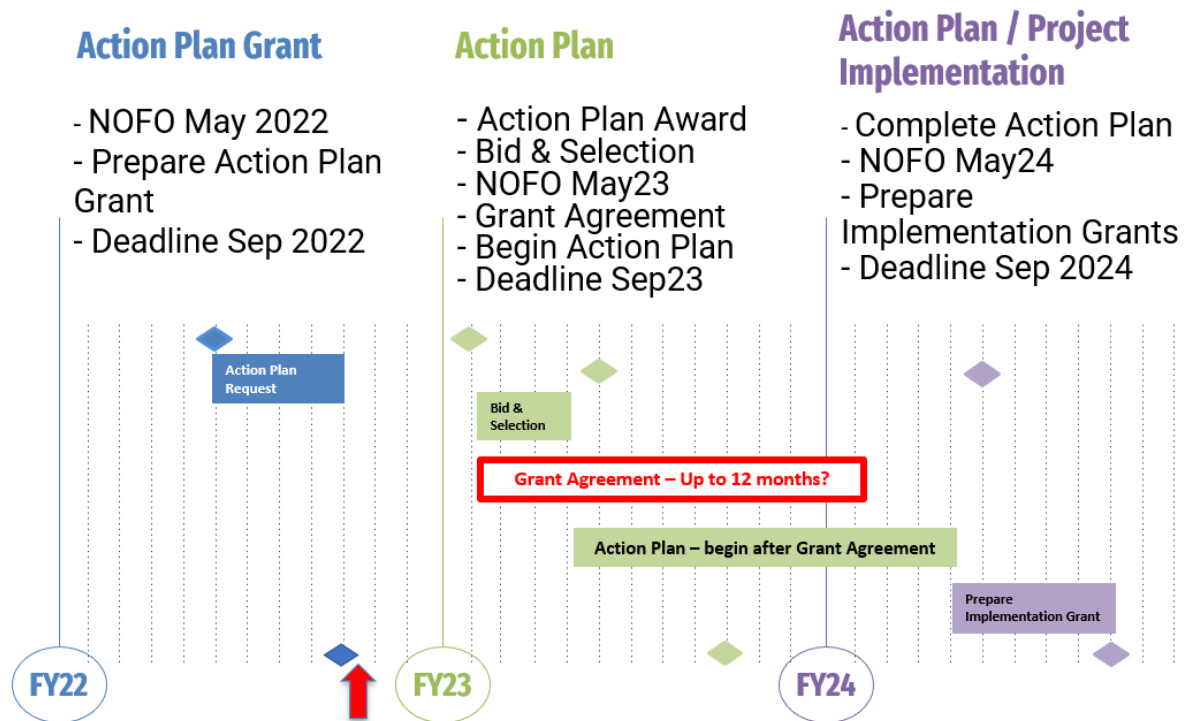
Lara McLellan reported on the SLC Transit Master Plan. Frequent Transit Network (FTN) routes were identified and increased frequency implemented, including expanded hours of service. The changes resulted in ridership increases, and SLC received positive feedback from the community. The new on-demand service and other pass programs have also been well received.
