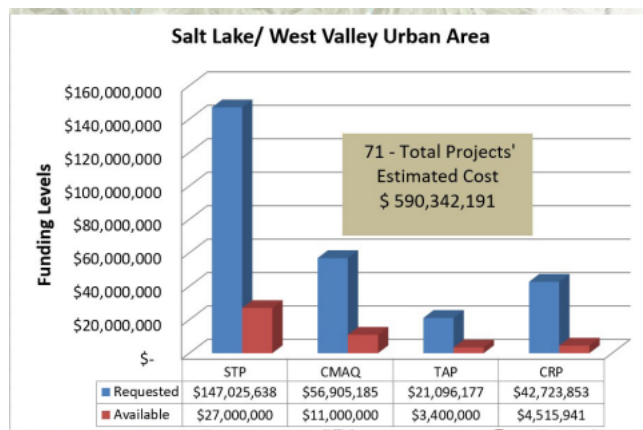
#### o Information Item – Review Schedule for the 2024-2029 TIP Process

After recommendations are made at today's meeting, there will also be a review by TransCom, and Salt Lake COG. Final approval will be considered by WFRC at the August 2023 Council meeting.
