Funding a project begins with nominations using an online Google form. Active transportation requires a 40% match, transit requires a 30% match. Nominations are due between June 26 to August 31. Transportation Improvement Program (TIP) Business Ben Wuthrich • Information Item - New Projects for the Draft 2024-2029 TIP for Public Review The 41 projects recommended at the March 29 meetings by the Ogden/Layton area and Salt Lake/West Valley area TACs have been approved by the WFRC Council for inclusion in the draft TIP. • Information Item – Review Schedule for the 2024-2029 TIP Process After Trans Com review in June, the draft TIP is anticipated to go out for public review and comment in July. The WFRC Council is expected to make final approval in August. 4. West Jordan City PresentationNate Nelson West Jordan is currently working on 5 projects: 7800 South widening 8600 South bridge - \$16M, complete by 2024 8600 South extension 9000 South extension - \$10M, complete by 2024 9000 South alignment – study, complete by 2026 Two of these projects are funded by the state legislature and would not be possible otherwise.

5. UTA 5 Year Service Plan Eric Callison

The UTA service plan is updated every two years. Needs are identified by public feedback, operating data, and growth projections. First ever UTA Long Range Transit Plan will also be a product of the planning process.

Changes in 2023:

New OGX line, Saturday TRAX service, Park City moves to HVT, and Flex route changes Changes 2024-2027:

Frequency and coverage increase on several routes including expansion to Eagle Mountain. Vision:

Added local service, on-demand service, Front Runner double track, LCC, and more. Bus operation in LCC would need to include service in BCC. It would require about 250 drivers and a separate garage and operating facility. A study is underway to evaluate provider options including expanded UTA, private provider, or a separate transit district.

UTA currently is deploying 22 electric buses at this time. Series 2300 buses (2023) are electric. Salt Lake Central is the only facility with charging stations at this time.
