### 3. WFRC Funding Programs







4700 South Reconstruction Project – 5600 West to 4000 West. Project cost is about \$31M. ROW and RR scheduling and coordination were challenges as expected.






5. Statewide Traffic Data & Uses - Kelly Njord & Nuzhat Azra





Speed and travel time data is available statewide for all roads classified as collectors and above. Users can register for an account. There is no charge for the data.

This is additional data beyond the PEMS data system which is radar based, whereas the Iteris data is vehicle probe data samples.

National Parks use this data to monitor parking lot capacity to inform travelers where to park using VMS displays.
