- 1. **Introductions and Consent Agenda [Recording 00:00:15].** Shawn Milne, Chair, called the meeting to order at 1:36 p.m. Roundtable introductions were made.
- a. **ACTION:** Minutes of the WFEDD Meeting held May 20, 2019 [Recording **00:03:55**]. Chair Milne entertained a motion to revise and approve the minutes of May 20, 2019.

A motion was made by Shawn Milne and seconded by Robert Dandoy that the Minutes of May 20, 2019 be approved without change. Motion carried unanimously.

- **2.** Chair's Report [Recording 00:05:00]. Abby Osborne, Chairperson, and Gage Froerer, Vice Chair were excused from the meeting. Commissioner Milne, past Chair, presided. There was no report.
- **3**. **Public Comment.** There were none.
- 4. Wasatch Front Economic Development District (WFEDD) [Recording 00:05:56].
- a. CEDS Progress Report and Implementation Step (Annual Objective #1: complete, adopt and report on 2018-2023 CEDS). With approval of the CEDS, the Economic Development Administration in Denver (EDA) expressed appreciation that the CEDS was able to coordinate with the Wasatch Choice 2050 process. Copies of the final CEDS report were available at today's meeting. Updated links to the WFRC web site will be electronically sent to the Committee. Scott Hess, WFRC, also mentioned that since the last WFEDD meeting, the committee has confirmed new members.

The Comprehensive Economic Development Strategy (CEDS) is a five-year plan that covers Years 2018 to 2023. Within the CEDS are four key strategies that were discussed: (1) Link development with transportation and other infrastructure; (2) Create fiscally sustainable places; (3) Provide amenities; and (4) Attract and retain businesses, and encourage innovation.

**Plan of Action: Next Step is Implementation**. With the adoption of CEDS in June 2019 comes implementation of each key strategy, along with promoting the Wasatch Choice Vision 2050 connection, and long-range planning decisions for transportation, land use, and economic development.

**b.** Informational: Wasatch Choice 2050 Vision Map and New Resources (Annual Objective #2: Promote Wasatch Choice 2050). A formal interactive map and Wasatch Choice 2050 poster were introduced by Ted Knowlton, WFRC, who gave an overview of the Vision. The map reflects what our region could look like in 2050 if land use and transportation projects are aligned properly. It has four key strategies: provide transportation choices, support housing options, preserve open space; and link economic development with transportation and housing decisions. WFRC is able to assist local governments in preparing plans for growth that maintain an enhanced quality of life and help implement our shared Vision. The key takeaway linking

economic development to the Vision is that Wasatch Choice and the CEDS consider a "where matters" approach to development. The location of jobs, housing, and open space is a critical consideration for us to accommodate the coming growth while maintaining our quality of life.

<u>Wasatch Choice Day</u>. During the upcoming weeklong conference with Utah League of Cities and Towns, September 12th will be dedicated to Wasatch Choice Day. This day will have breakout sessions for each of the four strategies, with keynote speakers addressing growth and the Vision.

<u>Miscellaneous Roundtable Discussions</u>. Jeff Edwards asked about employment centers with transportation that connect to residences. Mr. Knowlton stated that workforce accessibility is built in to Utah's Unified Transportation Plan and has a foothold in SB34. More discussions included funding issues with cities, such as Roy. There are traffic issues outside of Tooele when car accidents occur, which affects employers and delivery of goods.

In referring to CEDS, Chapter 5, Plan of Action, and SB172 for new Economic Development strategic plans, 15 to 20 working groups have been developed to make recommendations for the Governor's Office of Economic Development's new State Economic Plan. Those recommendations will be submitted to a national consultant in six weeks; then presented to the legislature in October.

<u>Transportation Reinvestment Zones (TRZ)</u>. TRZ provide a tax increment financing tool that ties redevelopment into investments for transportation. This is a new tool to help offset the costs of transportation infrastructure.

- c. Presentation: The Hub of Opportunity (Annual Objective #4: Inform stakeholders about economic development plans and strategies). Kristy Chambers, CEO of Columbus Community Center HUB, presented a unique approach to connect students with Autism Spectrum Disorder and their families to independent living. They are learning specific employment skills and accessing NeuroVersity, founded by Dr's. Scott and Cheryl Wright from the University of Utah. As part of becoming self-reliant, they will have opportunity for increased transportation accessibility through the transit-oriented development (TOD) which includes affordable units and job training on site. The Columbus Center HUB's grand opening will be in spring of 2020.
- 5. Informational: EDA CEDS Current Project [Recording 01:15:10] U.S. Ignite. Glenn Ricart from U.S. Ignite was present; and Arnold Liyai, Project Manager in Washington, D.C., joined by telephone. Mr. Hess explained that this Committee channels federal and economic development administration funds from the Federal EDA to create projects in the local region. U.S. Ignite applied with EDA who then contacted Mr. Hess; and they are now applying to have their project added to the CEDS project list. U.S. Ignite leverages new and existing smart city technology assets to develop high-skilled jobs in Salt Lake City for statewide coverage. It will also use opportunity zones for local investment. Staff recommended that this project not be added to the CEDS project list at this time, and would like U.S. Ignite representatives to provide additional details on the project before the WFEDD can support it.
