**1. Roll Call Introduction and Consent Agenda: [00:00:04]**

Commissioner Gage Froerer, Vice Chair, called the meeting to order at 1:37 p.m. Commissioner Froerer excused Abby Osborne, Chair, as she is unable to attend, due to today being the first day of the 2021 Utah Legislative Session. Introductions were made.

- a. **ACTION: Approve Minutes [00:02:41].** Commissioner Froerer entertained a motion to approve minutes of the WFEDD meeting held November 16, 2020.

*A motion was made by Chris Sloan, Tooele County and seconded by Mayor Jenny Wilson, Salt Lake County, that the minutes of November 16, 2020, be approved without changes. Motion carried unanimously.*

**2. Chair’s Report [00:03:40].**

Commissioner Froerer reported that the purpose of the WFEDD is to bring together the public sector and the private sector to address the regional economy. The WFEDD also supports projects for potential funding from the Economic Development Administration.

**3. Public Comment [00:04:07].**

Time was opened by Commissioner Froerer. There were no comments.

**4. Wasatch Front Economic Development District (WFEDD): (Annual Objective #2: Inform state, regional, and local stakeholders about economic development plans and strategies) [00:04:38].**

- a. **ACTION: Vote for Chair and Vice Chair Committee Positions – Commissioner Froerer [00:04:38]**

Commissioner Froerer reviewed the process in which a new Chair and Vice Chair were selected. He reminded the committee that the WFEDD is housed within the WFRC Council, but exists as a separate committee that has appointments from the Councils of Government from around the region and also private sector members. He stated that for all of the other committees at WFRC, there is a nominating committee that makes nominations for the Chair and Vice Chair of the Council and its committees. Technically the WFEDD selects its own Chair and Vice Chair. Nonetheless, the nominating committee has sent its recommendation to appoint Commissioner Gage Froerer, Weber County, the next WFEDD Chair. For Vice Chair, the nominating committee has sent its recommendation to appoint Mayor Debbie Winn, Tooele City.

*Commissioner Froerer entertained a motion to ratify the nominations as suggested by the nominating committee. Commissioner Bob Stevenson, Davis County, motioned to approve and it was seconded by Councilmember Mike Newton, Morgan County. Motion carried unanimously.*

**b. WFEDD Objectives Review and discussion of Wasatch Choice Regional Vision relationship to Economic Development – WFRC [00:07:10]**

Andrew Gruber, WFRC, reviewed the following WFEDD Annual Objectives with the committee:

1. Advance, update, and report on 2018-2023 Comprehensive Economic Development Strategy (CEDs).
2. Promote Wasatch Choice Vision as a coordinated growth, quality of life, and economic development strategy.
3. Integrate state, regional, and local transportation decisions with economic development efforts to improve access between workforce, housing, and jobs
  - Incorporate economic development into state, regional, and local transportation planning and funding
  - Incorporate growth patterns and transportation infrastructure into economic development decisions
4. Inform state, regional, and local stakeholders about economic development plans and strategies.

There being no changes or modifications to the WFEDD Annual Objectives, Commissioner Froerer reported that they will continue to move forward with them.

**[00:16:10]** Megan Townsend, WFRC, reported on the Wasatch Choice Regional Vision relationship to Economic Development. She stated that the Wasatch Choice Vision — the region’s blueprint for growth — embodies this coordinated approach, and is based on four key strategies that tie directly to economic development:

1. By Providing Transportation Choices, we support a more productive economy.
2. By Supporting Housing Options, we reduce household expenses.
3. By Preserving Open Space, we help retain and attract a quality workforce.
4. By Linking Economic Development with Transportation and Housing Decisions, we support better productivity, have reduced expenses, and are more attractive to employers and residents.

**c. Potential Economic Development Related State Legislation -- Ben Hart, GOED [00:34:46]**

Ben Hart, Governor’s Office of Economic Development (GOED), presented a preview of the plans and strategies that are anticipated to be discussed regarding economic development. Mr. Hart outlined the GOED processes and summarized the vision that is intended to be implemented to further Utah’s growth.

**d. WFRC City-level Sales Tax Trends Map, Resource -- Nicole Mendelsohn WFRC [01:01:58]**

Nicole Mendelsohn, WFRC, reported on the 2019 - 2020, city-level sales tax trend by quarter. Taxable sales are calculated by summing data from sales and use tax returns from the local sales tax distribution each month and aggregating by time period, location and industry category. Holin Wilbanks, Weber County, reported that even though 2020 was an unusual year, there was a huge uptick in industrial and manufacturing companies aggressively looking at Weber

County and David County for business. She also reported they are finalizing phase two of their mega site, which is 900-1200 acres of a new industrial park opportunity.

**[01:16:30]** Mayor Jenny Wilson, Salt Lake County, gave a report on the impact Covid-19 has had in the economy in Salt Lake County.

**[01:20:06]** Jevon Gibb, Salt Lake County Economic Development Director, reported on the efforts the organization is doing in working towards the recovery of the economy due to the Covid-19 pandemic.

**6. Other Business [01:21:40]**

Commissioner Froerer noted that the next meeting for the WFEDD is scheduled for February 22, 2021, at 1:30 p.m.

**7. Overview of Uta Open and Public Meetings Act and Adjournment [01:22:47]**

With no further business, Commissioner Froerer stated that Utah State law requires that elected officials serving on committees such as those of the Wasatch Front Regional Council receive training regarding the Utah Open and Public Meetings Act. Commissioner Froerer said that an 8-minute video would be shown in order to comply with this requirement and asked for a motion to adjourn the meeting upon completion of the training video. **[01:22:59]** Councilmember Mike Newton made a motion to adjourn the meeting upon conclusion of the video, and Mayor Jenny Wilson seconded. The affirmative vote was unanimous. **[01:31:32]** The video concluded, and the meeting adjourned at 3:31pm.
