## 1. Welcome and Introductions [00:00:01]

Commissioner Gage Froerer, Chair, called the meeting to order at 1:34 pm and welcomed the committee. Introductions were made, and Rosie Hernandez, WFRC, read the names of those in attendance.

## a. ACTION: Appoint Chair and Vice Chair [00:03:33]

Chair Froerer entertained a motion to ratify the WFEDD appointments as recommended by the nominating committee, and appoint himself as Chair, and Mayor Debbie Winn, Tooele City, as Vice Chair of the WFEDD. A motion was made by Chris Sloan, Group 1 Real Estate, and seconded by Mayor Karen Lang, West Valley City, to approve the Chair and Vice Chair as recommended by the nominating committee. Motion carried unanimously.

## b. ACTION: Approval of the December 13, 2023, Meeting Minutes [00:04:34]

Chair Froerer entertained a motion to approve the minutes of the WFEDD meeting held on <u>December 13, 2023</u>. A motion was made by Mayor Lang, and seconded by Ginger Chinn, Salt Lake City Chamber of Commerce, that the minutes of the December 13, 2023, meeting be approved without changes. Motion carried unanimously.

## 2. Chairs Report [00:05:16]

Chair Froerer took a moment to introduce and welcome the new committee members. [00:09:12] Chair Froerer shared the four key strategies of the Wasatch Choice Vision: Transportation Choices, Housing Choices, Parks and Public Spaces, and City and Town Centers. He stated that WFRC works with local communities, partners, and stakeholders to develop these key strategies, and reminded the committee that the key anchors and tasks within the newly adopted <u>2023-2028 Comprehensive Economic Development Strategy</u> (CEDS) augment these four key strategies of the <u>Wasatch Choice Vision</u>.

#### 3. Public Comment [00:18:00]

Chair Froerer opened the meeting to public comments. There were no public comments made.

#### 4. Economic Development 2024 Legislation - Ginger Chinn / Andrew Gruber [00:18:16]

Chair Froerer turned the time over to Ginger Chinn, Salt Lake City Chamber of Commerce, who provided a recap on the outcomes pertaining to the 2024 Utah Legislative Sessions. Ms. Chinn provided updates on legislative changes related to housing, transportation, workforce development, infrastructure, homelessness, economic development and business, and environmental, social, and governance.

[00:36:13] Andrew Gruber, WFRC Executive Director, presented a summary of the 2024 Utah Legislative Sessions. He reported on topics such as funding and appropriations, shared principles for infrastructure investment, and provided updates on key legislation. Some of the highlights reported by Mr. Gruber included the breakdown of a \$1.2+ billion budget towards transportation infrastructure and other growth related appropriations. ## 5. CEDS Implementation Priorities 2024 - Marcia White [01:03:27]

Chair Froerer turned the time over to Marcia White, WFRC, who provided a brief overview of the prioritized tasks outlined in the newly adopted <u>2023-2028 Comprehensive Economic</u> <u>Development Strategy</u> for the next five years.

## 6. Utah Broadband Center - Rebecca Dilg [01:09:40]

One of the several tasks with the CEDS is to support the implementation of broadband within the Region. Chair Froerer turned the time over to Rebecca Dilg, Utah Broadband Center, who provided a brief overview of the five-year digital connectivity plan that was completed last summer to help guide the state in increasing high-speed internet access. ### 7. Overview of the Utah Public Meeting Act [01:34:14]

With no further business, Chair Froerer stated that Utah State law requires that elected officials serving on committees such as those of the Wasatch Front Economic Development District receive training regarding the Utah Open and Public Meetings Act. Chair Froerer said that an 8-minute video would be shown in order to comply with this requirement and asked for a motion to adjourn the meeting effective upon conclusion of the training video.

## 8. Other Business & Adjournment [01:32:05]

**ACTION**: Mayor Winn made a motion to adjourn the meeting upon conclusion of the video, seconded by Mayor Kelly Bush, White City. The affirmative vote was unanimous. The video concluded, and the meeting adjourned at 3:16 pm.
