CHALLENGES

Utah communities face the dual planning challenges presented by rapid population growth and the effects of the COVID-19 pandemic. TLC can help communities face, plan for, and respond to these challenges.

INVESTMENT

Cities, counties, and transportation agencies are partnering together to fund implementation-focused planning efforts through the TLC program. The cumulative amount of investment in fiscal years 2014 through 2021 is shown below.



In 2021, TLC partners awarded \$1,378,500 to communities throughout the region. Communities matched with \$260,500, for a total of \$1,639,000 in region-wide funding.

WASATCH CHOICE

The TLC Program provides technical assistance to local communities to help them achieve their goals and plan for growth. This approach is consistent with the Wasatch Choice Regional Vision, a locally driven approach in which cities, counties, community organizations, transportation partners, businesses, and the public work together to create local solutions with regional significance that improve quality of



Project Development and Selection

The Transportation and Land Use Connection (TLC) Program selects projects using a set of evaluation criteria that are based on the goals of the program. Selected projects align with local community desires, addressing both transportation and land use needs. The TLC Program aims to guide projects through to implementation and encourages locally driven, multi-jurisdictional projects that have a significant and positive regional impact.


Project Outcomes

The TLC program brings together key stakeholders to make decisions that are efficient and implementable through integrated land use and transportation planning. The cumulative number and type of projects from 2014 through 2021 include:

The TLC Program supports projects that will make an impact throughout the region and implement the Wasatch Choice Regional Vision. Over two dozen TLC projects have collaboratively addressed land use, transportation, housing, and/or economic development across municipal or other boundaries to advance regional goals.

- 19 projects developed from collaboration between at least two communities
- 7 additional projects had a county-wide scope and thus fostered work among multiple municipalities.
- Active Transportation Plans comprise 42 percent of the multijurisdictional projects.
- Other multijurisdictional projects include corridor studies and master plans, parking studies, and market analyses.

Community Highlight: Taylorsville City

Taylorsville has utilized the TLC program to pursue one multijurisdictional and three independent projects. Taylorsville completed two small area plans, the Center Point Master Plan Vision Document and Small Area Plan, and the Commercial Centers Revitalization Master Plan. Both focus on linking redevelopment opportunities to transportation choices in key community areas. The Commercial Centers Revitalization Master Plan is highly implementation focused; it follows five principles: economic vibrancy, gathering, resilient redevelopment, building community identity, and connectivity enhancements.

Taylorsville has also focused on the connection between land use and active transportation (AT). Along with Millcreek, Cottonwood Heights, Holladay, Midvale, and Murray, Taylorsville recently developed the Mid-Valley AT Plan from 2019 TLC funds. This plan analyzed pedestrian and cyclists' needs and opportunities in all six communities while considering local and regional implications. The City will soon begin the Taylorsville Active Communities Plan, which received TLC funding in 2021. This plan will not only lay out AT design standards, but also produce a transit and pedestrian-oriented development manual and zone classifications for the transit corridor.

Community Highlight: Clearfield City

Clearfield has received five TLC awards throughout the program's duration. TLC has helped Clearfield pursue a general plan update, work with the Utah Transit Authority on both a station area plan and design guidelines at Clearfield Station, create a vision and implementation strategy for downtown Clearfield, and develop a form-based code for their downtown. Clearfield was also one of five communities funded for the multijurisdictional project, North Davis County Active Transportation Implementation Plan. This joint effort looked at connectivity of active transportation routes, safety, age and ability-friendly facilities, access, and the relationship of active transportation to transit. Additionally, Clearfield has just received an award for a parking study. They aim to right-size parking to positively impact different modes of transportation as well as the function of land uses at the site scale, further advancing their efforts to bring Downtown Clearfield to life.

Clearfield's Creating Downtown Clearfield, produced internally by WFRC staff in close collaboration with Clearfield staff and UTA, established a vision for the downtown area to be walkable, vibrant, and mixed-use, and to retain Clearfield's unique character. Clearfield's form-based code implements that plan. For example, the code establishes street connectivity requirements. Such requirements have a positive effect on pedestrians and cyclists by allowing the most direct and shortest traveling routes. Additionally, they distribute vehicular traffic, which minimizes congestion. The code also establishes standards for street facades in order to create a built environment that makes walking more attractive.
