

WHAT IS THE WFEDD?

The Wasatch Front Economic Development District (WFEDD) was created in 2014 under the umbrella of the Wasatch Front Regional Council (WFRC). The District includes Davis, Morgan, Salt Lake, Tooele, and Weber Counties, and is federally recognized by the U.S. Department of Commerce, Economic Development Administration (EDA).

The mission is to support economic development plans, promote long-term economic competitiveness, and attract federal monies to implement local plans.

The focus is regional economic development activities and the implementation of a regional comprehensive economic development strategy (CEDS). This is accomplished through the coordination of existing economic plans and cooperation with public and private sector organizations such as the Governor's Office of Economic Opportunity and the Economic Development Corporation of Utah.

The main economic interests and geographic diversity of the Wasatch Front region are represented by local elected officials, community leaders, and representatives from institutions of higher education, small business, and Chambers of Commerce.

The Wasatch Choice Vision is the blueprint for coordinating economic opportunity, infrastructure investments, development patterns, and job opportunities in order to create great places where quality of life is high, and the economy can thrive.

WHAT IS THE CEDS?

The Comprehensive Economic Development Strategy (CEDS) is a required economic plan that guides development for a stronger, more diverse economy for Davis, Morgan, Salt Lake, Tooele and Weber Counties is the primary responsibility of the District.

The CEDS is strategy-driven, collaboratively developed, and locally implemented. The strategies serve local decision-makers with setting priorities for investment in key economic development efforts.

REGIONAL STRATEGIES

The Wasatch Front Economic Development District and the Wasatch Front Regional Council have aligned the Comprehensive Economic Development Strategy 2018-2023 (CEDS) with the Wasatch Choice Vision (WC2050), the Regional Transportation Plan (RTP) and local land-use planning. This analysis allows for the identification of strategies that further comprehensive planning, economies of scale, capital investments and regional competitiveness while coordinating land development, infrastructure, and open space.
