

March 2020 marks the one year anniversary of our office moving to The Gateway! To say this was a good move would be an understatement! Our new office space and location has afforded us the opportunity of being closer to our partners and those of you that we work so closely with at the city and county level. As always, all of us at WFRC are thankful and appreciative of the relationships that we have with all of you.

### Wasatch Front Regional Council 2020 Legislative Session Wrap-Up

Another legislative session is in the books. We work with so many committed professionals from the public and private sectors... thanks for all you do!

Below is a summary of two of the fortyseven bills that WFRC tracked during the session, SB150 Transportation Governance and Funding Amendments and SB39 Affordable Housing Modifications are this year's 'big' transportation and housing bills.

<u>SB 150 2nd Sub</u>: Transportation Governance and Funding Amendments (Sen. Harper, R - District 6, Rep. Christofferson, R - District 56) - *Status: Passed* 

This bill enhances the coordination of transportation, housing, and land use at UTA Transit Oriented Development (TOD) sites. SB150 Sub2 passed unanimously out of the House and Senate. This bill was a focus for WFRC and our partners this year and was supported by many organizations. Here is our detailed summary of the final bill: <u>SB 150 Sub2 Bill Summary</u>. Here are a few of the provisions of this bill:

- Eliminates the cap on UTA TOD sites now allowing an opportunity for more municipalities to partner with UTA in future TOD developments.
- Ties the moderate income housing element of general plans and new station area planning requirements to TOD sites.
- Allows Utah's State Transportation Commission to give priority consideration to projects that are part of a transit-oriented/supportive development and/or a Transportation Reinvestment Zone.
- No later than 6/1/21, UDOT will identify how it will expand the RUC program to enroll all registered vehicles in the state no later than 12/31/31 and submit an annual report on the program's revenues, participation rate, and department costs from preceding and current fiscal years.
- The bill also modifies provisions related to local option transportation sales taxes;



class B&C road funds; transportation network companies; and tollways.

SB 39 4th Sub: Affordable Housing Amendments (Sen. Anderegg, R - District 13) - Status: Passed

SB39 is a follow up to last year's SB34 Affordable Housing Modifications bill that required cities to evaluate and create plans for how they address housing affordability issues in their cities. As you know, WFRC and our partners at the Utah League of Cities and Towns are continuing our work to implement and comply with SB34 (2019) as we work to correlate the transportation, land use, and housing elements of general plans. Stay tuned.

This year's SB39 focuses on funding for the development and preservation of affordable housing units. The fourth substitute passed both chambers with an appropriation of \$10 million in one-time funding to the Olene Walker Housing Loan Fund - of the \$10M, up to \$5M for private activity bond gap financing and up to \$5M to match private investment to preserve existing low-income housing units. Here is a <u>SB 39 bill summary</u> provided by Dept of Workforce Services.

Speaking of private investment to preserve existing low-income housing, a brand new program was announced earlier this month, led by the private sector, that targets housing preservation. The Utah Housing Preservation Fund was created by a joint partnership of the Clark and Christine Ivory Foundation, Intermountain Healthcare, and Zions Bank in partnership with Utah Nonprofit Housing Corp. #### Transportation and Land Use Connection 2020 Awards

We are pleased to announce the 2020 Transportation and Land Use Connection awards in collaboration with our program partners, UDOT, UTA, and Salt Lake County. The TLC program provides technical assistance to local communities to help them achieve their goals and plan for growth, implementing the Wasatch Choice Regional Vision.

### LeRay McAllister Critical Lands Conservation Fund

The Utah Quality Growth Commission announces the availability of funds and the opening of an application cycle for the LeRay McAllister Critical Lands Conservation Fund. Pre-Applications are due Friday, May 15th, 2020 by 5:00 PM. The LeRay McAllister

Critical Land Conservation Fund provides grants to preserve or restore critical open or agricultural land in Utah. Matching funds are required.

Due to concerns regarding the coronavirus, this application period includes an extended amount of time (8 weeks) for completing both the pre-application and full-application process. While we wanted to announce the funding as early as possible to allow entities to begin the process, we recognize that additional adjustments may need to be made if unforeseen circumstances arise and will notify you as soon as possible of any extensions to deadlines.

Eligible applicants are counties, cities, towns, the Utah Department of Natural Resources, the Utah Department of Agriculture and Food, and charitable organizations that qualify as tax exempt under Section 501 (c)(3) of the Internal Revenue Code.

Applying involves several steps. Before starting, be sure you have read the following attached documents:

- Schedule for 21st Application Cycle
- Pre-application Form
- Application Cover Sheet
- Application Checklist
- Application Form and Evaluation Criteria
- McAllister Fund Defining Principles
- Eligible Costs Policy

It is important that you know what will be required before a grant can be awarded so that you will be prepared to submit the required documentation.



# Central Wasatch Commission Call for Project Ideas

The Central Wasatch Commission is pleased to announce the launch of a Call for Ideas for new projects specific to the project area of the Central Wasatch Commission, which includes Millcreek



Canyon, Big and Little Cottonwood Canyons, and the Wasatch Back.

This Call for Ideas is specifically focused on projects that improve canyon transportation or transit, protect the ecosystems or watershed originating in the project area, steward year-round recreation, and sustain the economic viability of the Wasatch Canyons. These were the tenets laid out during Mountain Accord, and form the basis for the work of the Central Wasatch Commission. Idea submissions will be accepted on a rolling basis, but priority will be given to those submitted by Friday, April 3 rd 2020.
