Welcome and Introductions – Spencer Brimley, Clearfield City Community Development Director	Spencer Brimley, Community Development Director at Clearfield City introduced the meeting and welcomed the attendees. RGC TAC was held via Google Hangouts	None Required
1. Meeting Summary – February 19, 2020 Minutes	Spencer Brimley, Community Development Director at Clearfield City, called for a motion to approve the February 19, 2020 minutes.	Approved
2. Action Item: Amendment #1 to the 2019-2050 RTP Jory Johner, WFRC Long Range Planning Manager	Jory went over the recently approved RTP Amendment Process, along with two staff level amendments, and seven proposed Board-level amendments to the 2019–2050 Regional Transportation Plan. WFRC, in consultation with our transportation partners have been working to update the Amendment process to make it more streamlined for public input. There are three levels for amendments and each level has a different process. Jory went on to describe the different level types for amendments and went over the two level Amendments and the seven level 2 Amendments. After reviewing the projects, Jory stated that the next step would be to bring these modifications to the Regional Growth Committee on May 21, 2020. 3. Legislative Recap LaNiece Davenport, WFRC Government Relations Director	LaNiece provided highlights of some key appropriations and bills that passed during the 2020 Legislative Session. She covered planning-related appropriations, such as the Frontrunner Strategic Business Plan, Point of the Mountain Alternative Analysis for Transit, and Electric Vehicle Charging Infrastructure. LaNiece went over several bills:	None Required

	 SB 39 Affordable Housing Bill which passed this year. This bill is important because it's the appropriations piece to SB24. This allows \$10 million one-time funding to the Olene Walker Housing Loan Fund through the Department of Workforce Services. SB 115 Bonding Amendments Bill, passed. WFRC didn't take a stance on this bill but it has important provisions, including UDOT shall study transportation connectivity in the southwest valley of Salt Lake County. The bill also allows the State Infrastructure Bank (SIB) funds to be used for construction. SB 122 requires UDOT to provide a report regarding the number of moderate-income housing units lost due to actions by UDOT. SB 150 eliminates the cap on future Transit-Oriented Developments (TODs). It also ties the moderate-income housing element and new station areas to TOD planning. This legislation also requires UDOT to define how they will expand the Road Usage Charge (RUC) program to enroll all registered vehicles no later than December 31, 2031. Angela Price, Co-Chair of the American Planning Association Legislative Committee, spoke about HB 374 Building Regulation Amendments. This bill waives the building design elements for the Moderate-Income Housing plans for cities. APA-Utah did a legislative update yesterday. 4. TLC Awards Megan Townsend, WFRC TLC Manager	Megan Townsend, WFRC Transportation Land Use Connection Manager went over the 2020 projects awarded. There were 17 projects awarded this year, six of which were in the Ogden-Layton Urbanized Area, two in Tooele County, and the rest in Salt Lake City-West Valley City Urbanized Area. Five of the 17 projects were multi-jurisdictional projects. There were several regional project efforts including the West Davis Corridor Market Analysis, some general plan updates awarded such as the Clearfield City General Plan, Farmington City Land Use Element, Fruit Heights General Plan, Hooper City General Plan and Sunset City Form-Based-Code. Scott pointed out that some of these topics may not be ripe to discuss with local communities facing tax and other budgetary shortage issues and the focus on trainings would be to provide assistance not necessarily to planning staff at cities but more the planning commissioners, city councils, local elected officials, and others that might not have the same opportunity in training as planning staff. With that Scott opened it up for questions, and asked the group what training would be most beneficial.
